**IMPORTANT NOTICE:** The Registered Guardian Certification Exams are administered and conducted by the Center for Guardianship Certification (CGC). Review Courses for the exams, along with study materials, are provided by the National Guardianship Association (NGA). The exams and courses are run by different organizations to maintain the integrity of the certification process, which means registration is a two-step procedure and payment must be made separately to each organization. Study materials may also be ordered for independent learning. In instances where there is a state specific exam, the review course will include all available guides for that state. Those applying for state specific exams should always verify requirements and procedures with their state authorities. Please note that the NGA Review Course does not fulfill Florida's requirement that their exam applicants complete a 40-hour course approved by the Florida Public Guardianship Office.
