NGA is providing this form electronically to make maintaining attendance records easier for attendees. Please follow the below instructions to utilize this new feature.

If submitting electronically, you are not required to return the paper copies to the registration desk. NGA will verify via email, the receipt of all electronic verification sheets within 2 business days of receipt.

This form uses Adobe Reader (a free app available for download in most app stores), if you do not already have this app, you must download it from your app store in order for it to open and save information properly on your device.

1. You must **FIRST** download/save the file to your device. Not downloading first will result in loss of ALL data upon closing of the document.
2. **SAVING THE DOCUMENT** – If you were not asked to download this file prior to opening, it opened on the web version of Adobe Reader. To download the file, you should see a save icon at the top right of your internet window. If you do not see an icon, you should be able to right click on the document itself (be sure you are not clicking over a fillable field) and click on the “Save as” option. When saving, be sure you are aware of the location the file is saved to.
3. **ACCESSING THE DOCUMENT** – Once downloaded, you can access it on your device and continue with the inputting of codes. Be sure to “SAVE” after inputting each code.
4. **PRINTING** - If your device has the capability, you can follow your devices instructions to print.
5. **SUBMITTING YOUR COMPLETED FORM VIA EMAIL** - When clicking submit, the system will ask for the method of email you use, either outlook/device based, or a web version. If you use outside account that is not connected to your device, you will need to email the document on your own by logging into your email account, attaching this document to an email and send to education@guardianship.org. If you use outlook or a device-based email, the program will open an email with the document attached and the “To” box already completed, with you only needing to press “Send” to submit your sign in sheet electronically.
